Students in the L/T Mediation Clinic are trained in the basics of mediation and are given the important responsibility to facilitate mediations in active landlord-tenant cases in Suffolk County District Court. Students will learn the basics of landlord-tenant law and mediation techniques. Seminar will include simulations exploring negotiation and alternative dispute resolution. This clinic will provide a critically important service to litigants and judges in landlord-tenant matters. It is anticipated that housing courts will receive a crush of cases due to the expiration of eviction moratoriums, uncertainty of unemployment insurance benefits, food insecurity, and other challenges posed by the pandemic. Students will also develop negotiation skills, proficiency in mediation, and knowledge of landlord-tenant law and court procedures.
