#### **DEFENSIVE DRIVING COURSE**

Staff members can take the NY State-approved six-hour Defensive Driver Course at the Law Center Wednesday-Thursday July 6-7, 4:00-7:00 p.m., each day. Staff members who successfully complete the course are eligible for 10% off their auto insurance and up to 4 points off their licenses. # FREE MPRE COURSE

The Multistate Professional Responsibility Exam (MPRE) is a national two hour and five minute sixty-question multiple-choice examination, administered three times each year. A passing score is required for admission in virtually every US jurisdiction. The registration deadline for the Friday, August 6 MPRE is Tuesday, June 29. Late registrations will be accepted through Thursday, July 15, at double the normal \$63 fee.

On Sundays, July 25 and August 1, 11:00 a.m.-3:00 p.m. each day, Professor Theodore Silver will present a free MPRE preparation course. Professor Silver is a nationally recognized test preparation expert, and the author of several books on study strategy and test-taking techniques. #### TISHA B'AV

The Jewish holiday of Tisha B'Av falls this year on Monday, July 19. Tisha B'Av is the saddest day in the Jewish calendar, because of the incredible series of tragedies that have occurred on that date throughout Jewish history. Tisha B'Av (literally, the ninth day of the Jewish month of Av) is a day of mourning, primarily to commemorate the first and second Temples, both of which were destroyed on the ninth of Av (the first by the Babylonians in 586 B.C.E.; the second by the Romans in 70 C.E.). Among the many other tragedies that occurred on this day were the expulsion of the Jews from Spain in 1492, the start of World War I (which began the chain of events that led to the Holocaust), and the World War II deportation of Jews from the Warsaw Ghetto to the Treblinka concentration camp. Tisha B'Av is the culmination of a threeweek period of increasing mourning. From the first to the ninth of Av, observant Jews refrain from eating meat or drinking wine (except on Shabbat) and from wearing new clothing. The restrictions on Tisha B'Av itself are similar to Yom Kippur prohibitions: no eating, no drinking (even water), no washing, no bathing, no shaving, no wearing cosmetics, no working, and no studying Torah.
